Islip Fete -looking for additional tables. Volunteers welcome first thing to help put up Gazebos/tables.

First Responders made contact and will be there on the day.

Councillors resolved to approve a one-day suspension allowing dogs onto recreation ground for the duration of the Fete. Clerk to make a Notice for the day

Newsletter- Limited copy for next one, deadline has had to be extended.

Bowls Club- have a Lottery grant for an irrigation system and need permission to route it around along a path. Councillors resolved to approve this request

19/19 To receive District & County Councillors' reports.

ENCIIr Carter reported that Government had finally given go ahead for the two Unitary Authorities, to commence in 2021. A shadow cabinet will be elected in 2020.

Thrapston Library had meeting with NCC, as still looking to buy the library- Business plans etc needed- may become a community venture.

NCC doing a consultation for children and young people with Care Plans to see where there are gaps.

Beat the Street was successful, the legacy of this is to encourage health and well -being and be Active and connected.

Had meeting with Highways, Market organisers, Local school, as on market days, with all the traffic, no room for emergency vehicles- unsafe for children.

District Cllr Brackenbury had sent a report in echoing the news about Unitaries, and also that Government has announced Children's Services will become a standalone Trust which will deliver services for the two new unitary authorities across the County. These new unitary authorities will be established on 1st April 2021.

19/20 Clerk's Update

- 1. Website- New theme introduced was not unanimously supported. One resident had responded to offer assistance, Clerk to liaise
- 2. Northants Police- new mobile phone reporting app
- 3. Insurance premium has increased by £29.74 due to the addition of the new play equipment-renewal Oct.
- 4. Western Power are relooking at replacing substation near Bowls Club, will cover all costs incurred to Parish Council

19/21 To receive the round the table comments –

Large delivery lorries coming over the bridge.

East Northants Community Fund- Cllr Maxwell would like to upgrade floodlights to increase usable area-to help walking football and junior football. Lights will be directed down to avoid light pollution. c£16,000 quote- need £10-11,000. Cllr Taylor put forward a quote for resurfacing recreation path c£13,000.

It was unanimously agreed that the SFA should apply to the CFF for a grant for lighting as it was the best project to promote and expand active lifestyles in the local community with focus on the older age range Walking Football, and to get juniors more active
